WELCOMING OVER 200,000 VISITORS ANNUALLY, EDVENTURE IS COMMITTED TO MAKING SURE EVERY CHILD HAS ACCESS TO THE BENEFITS OF INFORMAL EDUCATION. DUE TO THIS COMMITMENT, 31% OF GUESTS ENTER THE MUSEUM WITH FREE OR REDUCED PRICE. EDVENTURE HAS FOUR MAIN AREAS OF FOCUS: EARLY LEARNING, HEALTH AND NUTRITION, STEAM EDUCATION, AND YOUTH AND WORKFORCE DEVELOPMENT. BY FOCUSING ON THESE AREAS, EDVENTURE IS ABLE TO ANNUALLY PROVIDE: OVER 4,500 FREE BOOKS TO UNDERSERVED HOUSEHOLDS, OVER 5,000 FREE SUMMER MEALS TO BRIDGE THE SUMMER NUTRITION GAP, MORE THAN 9,000 CHILDREN WITH HEALTH AND DENTAL PROGRAMMING, OVER 26,000 STEAM EDUCATION OUTREACH PROGRAMS, AND MORE THAN 4,500 UNDERSERVED TEENS WITH WORKFORCE DEVELOPMENT AND EMPOWERMENT PROGRAMS.
